- **Property Purchase**: We should close on Wednesday! Financial documents are being prepared and the Term-Sheet has been signed. Mr nelsen will discuss the "deal" and seek input on immediate priorities for restoration of the facilities. (att: 3-a,b,c)
- I ♥ Rockwood: My Nelsen requests a \$2,000 contribution for the annual community festival. Over \$25,000 has been raised so far and we are shooting for \$30,000. Other sponsors Include: Gresham, Community Development Partners and Mult County! This year's event will be held on SUNDAY AUGUST 28th at the new "Downtown Rockwood" Complex (SE Stark/approx 2 blocks from RPAcampus) and will feature:
 - 60 non-profit partners
 - Medical Serices
 - Free Hair Cuts
 - Live Music
 - Free Backpacks/School Supplies
 - Free Community Meals (est: 2,500 meals!)
 - Midway games and family activities

- **Menstration Dignity Act Grant**: The admin requests BOD approval to enter into an agreement with Reynolds school district that will foster the school's compliments with Oregon's Menstration Dignity Act. The goal of the act, according to guidance issued by the Oregon Department of Education, is to help those who get their period more actively and comfortably participate in school by "alleviating economic strain and experiences of shame that are often barriers for menstruating students accessing their education." The products are being placed in all bathrooms, so that "all students, in all grades, including those who are transgender, intersex, nonbinary, can access their education without barriers," NOTE: as a state law RPA must comply. (att 4)
- **Public to Be Heard:** The board provides this opportunity for community members to make comments to the board on matters pertaining to the school. To ensure that as many people that wish to make comments get that chance, the Board respectfully asked that comments be no more than 5-min in length. Persons want to make public comment during the COVID health crises should pre-arrange with Mr. Nelsen (jnelsen@rockwoodprep.org) to ensure access and opportunity.
- **Executive Session**: The KNOVA Board will recess into executive session to A) To consider the employment of a public officer, employee, staff member, or individual agent, and B) conduct deliberations with persons designated by the governing body to negotiate real property transactions as provided for in ORS 192.660(2)(a)(e)
